## **REACH Conformity Declaration Regulation (EC) No. 1907/2006 – REACH**

Webcraft deals mainly with magnets. According to the current interpretation of the chemical legislation, the REACH regulation, magnets are not considered as “articles”, but as (chemical) “mixtures”. As a result, our products must meet far stricter requirements, that go beyond the general information requirements of Article 33 of the REACH Regulation. All our magnets have been risk-evaluated in full for all relevant uses by scientific experts and have been registered in full with the European Chemicals Agency (ECHA).

Webcraft also deals, as far as the function of our products is determined primarily by their shape and form (e.g. magnetic foils), with products that are considered as “articles” in the scope of the REACH regulation. We source these products from European and non-European suppliers.

The same applies to (magnetic) packaging, which are also considered as “articles”. With respect to such products, which are to be considered as “articles”, as well as with regard to the packaging, we hereby confirm that our products do not contain any harmful substances that are listed in the current version of the Candidate List (in accordance with Article 59 REACH (status: 25.06.2025, 250 substances)) in concentrations of more than 0.1 mass -%.

The list of substances of very high concern (SVHC) is expanded twice a year and is available on the websites of the European Chemicals Agency (ECHA) under <https://echa.europa.eu/candidate-list-table>

We take these information requirements and our product safety very seriously. The legal requirements according to Art. 33 of the REACH Regulation are met by the following procedure:

1) As a basic principle our EU suppliers are obliged to proactively inform us without due delay, if in the supplied products any SVHC over 0.1% by mass are contained. As soon as we will receive any related information from our suppliers we provide this information according to Art. 33 of the REACH Regulation immediately to you.


After a thorough examination of all products and based on the available information our supplied products are not expected to contain SVHC in concentrations above 0.1%.
